Dana Splichal with SCC, CPAS presented to the council the 2020 Audit Report. She reported a clean audit. The City of Seneca, Kansas's financial statement need to be filed with the state by December 31, 2021. This will be on the October 6th, city council's agenda to approve.

Tami presented to the council the hay bids received for the 2022 and 2023 seasons. The high bidder for Maxwell Springs is Cole Deters at \$410 per year and for the airport is Roger and Jason Deters at \$1450 per year.

Mike Stallbaumer made a motion to approve a lease agreement with Cole Deters at \$410 per year for the 2022 and 2023 seasons for the hay ground at Maxwell Spring. The motion was seconded by Ray Shinn. All voted yes. Motion carried.

Mike Stallbaumer made a motion to approve a lease agreement with Roger and Jason Deters at \$1450 per year for the 2022 and 2023 seasons for the airport properties hay ground. The motion was seconded by Ray Shinn. All voted yes. Motion carried.

Ray Shinn made a motion to approve the appointment of AJ Heinen to the Planning Commission, term to expire September 2024. The motion was seconded by Kylee Bergstrom. All voted yes. Motion carried.

Jim Mitchell made a motion to approve an application for a Special Event CMB for the Seneca Area Chamber and Downtown Impact during Oktoberfest of October 9th from 3:00 p.m. to 7:00 p.m. The motion was seconded by Steve Bennett. Jim Mitchell, Steve Bennett, Ray Shinn, Mike Stallbaumer and Alice Lackey voted yes. Kylee Bergstrom abstained. Motion carried.

Jim Mitchell made a motion to go into executive session for a period of 30 minutes beginning at 8:00 and ending at 8:30 p.m., to include the governing body, Tami, Martin Mischler and Erik Ganstrom for the purpose of attorney client privilege. The motion was seconded by Kylee Bergstrom. All voted yes. Motion carried.

At 8:30 p.m., Kylee Bergstrom made a motion to extend executive session until 8:45 p.m. The motion was seconded by Jim Mitchell. All voted yes. Motion carried.

At 8:45 p.m., Jim Mitchell made a motion to extend executive session until 8:55 p.m. The motion was seconded by Kylee Bergstrom. All voted yes. Motion carried.

At 8:55 p.m., Jim Mitchell made a motion to extend executive session until 9:00 p.m. The motion was seconded by Kylee Bergstrom. All voted yes. Motion carried.

At 9:00 p.m., the governing body reconvened in open session. Steve Bennett made a motion to authorize filing of covenants for the Fairway Addition #2 as amended. The motion was seconded by Kylee Bergstrom. All voted yes. Motion carried.

Alice Lackey made a motion to adjourn. The motion was seconded by Jim Mitchell. All voted yes. Motion carried. Meeting adjourned at 9:05 p.m.
